





Executive Summary

Executive Summary

In the face of the dispiriting information of the adjacent panel, and today's uncertain global landscape, ECoLibri remains steadfast in its belief that it offers support in enhancing transparency via its ESI modelling.

Simply addressing the improvements detailed in page 15 of this review would deliver a notable step forward for many companies.

ECoLibri's Scope: 98% is Europe and the Americas. Some European companies are regional headquarters of American, Japanese, Chinese, Indian conglomerates. Just over half of the companies operate in satisfactory / reasonable risk areas, with only 41% in very low / low risk environments. Revenues of 2.7 trillion euros are covered across the 15 business sectors.

In 2024 ECoLibri structured the listed companies in a 6-tiered system, see page 8 whereby tiers 1 & 2 recognise those companies with the greater transparency and eligibility for ranking.

Our work to assess the transparency of sustainability reports starts with the SDG-Strategy. Many opportunities for improvement in the short term, to contribute to a better planet, concern the following sectors: Equipment OEM, Parts & Services, Inks, Pallets, Transport, Staffing & Security.

In addition, to strategically contribute to a better planet, the companies must be transparent in Implementation.

Sectors that must improve in 2025 their disclosure of Best Practices: Equipment OEM, Inks, Pallets, Transport, Staffing & Security, Waste Recovery.

Our third focus area is a critical quantifier: the Measurement relevant with SDGs and Best Practices.

Sectors that must improve their disclosure of metrics are Agri-Food, Inks, Pallets, Transport, Staffing & Security, Waste Recovery.

In 2025 ECoLibri will increase their targets for the S.I.M. elements of the ESI calculations following review and reflection of the leading companies best transparency practices.

Extract from the UNGC 2024 report 'Progress towards the SDGs' On track or target met 17% **Moderate progress** 18% 30% **Marginal progress** 18% Stagnation Regression 17%

This alarming slow progress is why the UN Global Compact launched Forward Faster, an initiative that aims to increase accountability and transparency calling for companies to publicly declare their commitments and highlight the actions they will undertake to meet the targets.

These disappointments are echoed by ECoLibri where, due to limited sustainability declarations, from 638 companies screened only 430 could be listed from whom only 166 were sufficiently transparent to facilitate an ESI measurement with only 19 of these attaining the ECoLibri target level.



ESI Selection & Distribution

Focus on ESI



CASCADE FROM THE LIBRARY TO THE SELECTED COMPANIES

ECoLibri's Library contains 423 companies in 20 sectors. We have selected 15 of them, and their 360 companies delivering key materials, goods & services or commodities, excluding banking and Insurances.

TIER 4 companies (126) are excluded as they do not provide information on sustainability strategy, implementation or performance measurement in their website or in an annual report.

TIER 0 companies (20) are candidates for a future screening.

TIER 3 companies (23) are those with partial information on their SDGs (Strategy) and on their metrics (Measurement). We have not yet performed a scan of their Best Practices (Implementation).

TIER D companies (25) are those active in more than one of the selected 15 sectors.

TIER 1 and TIER 2 companies (166) have sufficient information in S.I.M. They enter the ECoLibri Sustainability Index (ESI) and the ranking table.

DISTRIBUTION OF THE ECOLIBRI SUSTAINABILITY INDEX (ESI)

At the end of 2024, 63% (104) of the selected companies within the 15 sectors have an ESI higher than 60%.

Another 25% (41) companies have an ESI between 30% and 60%. These companies are moderately transparent on all of their S.I.M. They require short-term improvements.

The rest of 13% (21) companies with an ESI lower than 30% are definitely not transparent on Implementation and on Measurement. They require immediate improvements.

Compared to 2023, the change is not significant.

ESI Ranking Focus on ESI

ESI Ranking

Aligned with its mission statement ECoLibri believes that true transparency requires a company to publicly document their sustainability strategy, the operational practices to deliver this together with supporting ESG performance data (usually via a sustainability report).

Only one quarter of the companies researched by ECoLibri publish sufficient evidence to enable the ESI to be calculated!

There is an evident and urgent need for companies to improve their sustainability transparency which can be objectively quantified via the ESI.

As last year the spread within sectors remains of concern with every sector exhibiting a minimum of 50% variance in ESI, again reflecting the evident need for improvement even where the ESI is measurable.

The sector exhibiting the greatest annual improvement is Plastic & Films, Strapping with Industrial Tapes showing the greatest annual fall.

The top 3 ranked companies of those with an ESI in 2024 are:

- 1. SCA Container Board (Sector: Paper & Packaging)
- 2. Smurfit Kappa; pre-merger (Sector: Paper & Packaging)
- 3. Reno De Medici (Sector: Paper & Packaging)

Despite the top 3 all belonging to the same sector (Paper & Packaging) this sector has slipped to no. 2 in the sector rankings with the leader being Energy.

Within the ESI structure core elements of strategy, implementation and measurement (S.I.M) the percentage performance levels, by number of ranked companies (166), in 2024 are:

Strategy: Good = 51%; Satisfactory = 48%; Poor = 1% Implementation: Good = 28%; Satisfactory = 68%; Poor = 4% Measurement: Good = 42%; Satisfactory = 37%; Poor = 21%



Comments

Whilst the overall average performance has slipped marginally to 59% (60% in 2023) the spread across sectors of 17 percentage points is encouraging. 6 sectors are at, or above, the ECoLibri target.


The 3 most selected SDGs (7,12,13) mirror those nominated by ECoLibri to be classified as 'Global'.

It is disappointing to note the low selection and zero movement of the 'Pathway' SDGs as ECoLibri firmly believes these to be the route forward for todays troubled world. The 'Planet' SDGs show some improvement but not at an expected rate to realise the UNGC goals.

Highest performance sector is Forestry, up 2 places from 2023. Notable sector ranking improvements in 2024 are Waste Recovery, up 9 places, and Agri-Food, up 4 places.

Lowest performance sector is Transport, slipping 3 places from 2023. Notable sector ranking regressions in 2024 are Pallets, down 5 places, Adhesives, down 4 places, and Equipment OEM, down 4 places.

SDG Strategy Consensus

Focus on Strategy

High Consensus over the 17 SDGs?

Besides the three "global" SDGs, the sectors share a high consensus, to a large extent on SDG 8 (decent work), and to a limited extent on SDG 5 (gender equality). A major disappointment is the lack of a high consensus on other PEOPLE and PATHWAY SDGs.

Where the companies share a high level of consensus, the supply chains have the most rapid and robust impact on ESG.

Low Consensus over the 17 SDGs?

It is a concern that last year's reports confirm the trends of a low consensus in several ESG areas and ECoLibri's 4 Ps.

Almost unanimously on SDG 1 (poverty) and SGD 2 (hunger), to a very large extent on SDG 11 (cities), SDG 14 (life under water), SDG 16 (justice and peace), and to a large extent on SDG 4 (education), SDG 10 (inequalities) and again SDG 15 (life on land).

Where the companies do not share a consensus, the supply chains lack the opportunity to have a rapid and robust impact on ESG.



Focus on Implementation



Comments

The overall average performance has improved to 65% (62% in 2023). The spread across sectors of 11 percentage points is encouraging and reflective of the highest scoring section of the scan being 'Improvement & Innovation'.

The downside is that no sector has achieved the ECoLibri target. This is somewhat driven by the lowest scoring sections of the scan being 'Quality System' and 'Performance Reporting' thereby reflective of a reluctance to publish quality policies and certifications and QSHE metrics.

Highest performance sector remains Paper & Packaging. Notable sector ranking improvements in 2024 are Equipment Parts & Services, up 6 places, and Plastic & Films, Strapping, up 4 places.

Lowest performance sector is Pallets, slipping 1 place from 2023. Notable sector ranking regressions in 2024 are Waste Recovery, down 6 places, and Staffing & Security, down 5 places.




Whilst the overall average performance has improved to 66% (57% in 2023), with 4 sectors exceeding target, the spread across sectors of 37 percentage points is disappointing and is mirrored in the wide spread of transparency in data reporting across individual companies within certain sectors.

Reporting is notably lagging in certain safety (excepting frequency rate) and raw material metrics (key to supply chain sustainability). Waste and training metrics are those seen to be the most variably reported across the sectors.

Highest performance sector remains Paper & Packaging. Notable sector ranking improvements in 2024 are Plastic & Films, Strapping, up 8 places, and Inks, up 3 places.


Lowest performance sector is Pallets, slipping 1 place from 2023. Notable sector ranking regressions in 2024 are Industrial Tapes, down 4 places, and Staffing & Security, down 4 places.

The company ranking

The leader in transparency within this sector is ARKEMA, followed by HENKEL, 3M, DOW and DUPONT. The companies with the highest potential ESI improvement are QUILOSA-SELENA, JOWAT, H.B.FULLER.

The sector transparency level

We rank transparency quantifiably within 15 sectors along the selection of the SDGs to which the companies contribute or impact, the implementation of Best Practices, the relevance of the shared Metrics recommended by ECoLibri for the better of the planet. The sector ranks 6/7/6 (last year: 2/8/5).

What goes well ... and not so well

The companies select on average 9 SDGs (our target is 10); they share a higher consensus than the target (68%, target 60%). Besides the 'Global" SDG 7, SDG 12 and SDG 13, the companies tend to prioritize SDG 8.

They also reach a moderate consensus on People (SDG 3, SDG 4, SDG 5, SDG 6), Prosperity (SDG 9, SDG 10, SDG 11) and Pathway (SDG 17). Over our unique 7 section-scan, they share an acceptable amount of best practices (score 66%, target 70%), although we signal weaknesses in quality-, metrics- and environmental systems.

The average fill rate of the ECoLibri-Performance Data Reporting is close to our target (score 72%, target 77%).

The reporting level within the sector

On average, 30% of the workforce are women.

Many companies in our selection (85%+) report, to varying levels of detail, data on safety, energy, emissions, water, waste. Only 67% of them disclose data on training and 27% on raw material input.

Waste Recovery

The company ranking

The leader in transparency within this sector is URBASER, followed by BIFFA, VEOLIA, RENEWI and STENA. The companies with the highest potential ESI improvement are SUEZ ENVIRONMENT, RAGN SELLS, BNEXT.

The sector transparency level

We rank transparency quantifiably within 15 sectors along the selection of the SDGs to which the companies contribute or impact, the implementation of Best Practices, the relevance of the shared Metrics recommended by ECoLibri for the better of the planet. The sector ranks 3/11/11 (last year: 12/5/9).

What goes well ... and not so well

The companies select on average 8 SDGs (our target is 10); they share a higher consensus than the target (64%, target 60%). Besides the 'Global" SDG 7, SDG 12 and SDG 13, the companies prioritize SDG 3, SDG 8 and SDG 11.

They also reach a moderate consensus on People (SDG 5, SDG 6) and on Prosperity (SDG 9 and SDG 10).

Over our unique 7 section-scan, they share an acceptable amount of best practices (score 65%, target 70%), although we signal weaknesses in quality-systems.

The average fill rate of the ECoLibri-Performance Data Reporting is acceptable (score 58%, target 77%).

The reporting level within the sector

Many companies in our selection (80%+) report, to varying levels of detail, data on emissions and raw material input. Only 60%+ of them disclose data on safety and energy, 47% on training and 40% on water and waste. On average, 21% of the workforce are women.
